FAT DADDY'S MIXED USE PROJECT

Ed and Lisa Braude have owned the popular Fat Daddy's restaurant since the 1980's. Three years ago they purchased this three story building located at S. Baltimore Avenue and Dorchester Street. In the past year they decided to redevelop the property due to its poor condition. Thanks to the efforts of the Maryland Department of Housing & Community Development, a local bank, and the OCDC, the new project is currently under construction. DHCD provided a grant towards the demolition and preconstruction costs as well as a gap financing loan. The new building will have a larger Fat Daddy's restaurant and retail bay on the first floor. The second floor will provide housing for expected to be completed for this 2013 summer season.

Revitalizing DOWNTOWN OCEAN CITY ONE BUILDING AT A TIME

As of February 1, 2013 a total of 134 buildings have been renovated using the OCDC Façade Program in downtown Ocean City south of 17th Street. There are currently 9 façade projects underway. The OCDC Façade Program has had a tremendous impact on the appearance of many buildings. To date, over \$4.7 million has been invested into downtown Ocean City through this program. These newly renovated projects greatly increase the taxable value thus benefitting all Ocean City and Worcester County residents. Funding for the OCDC Façade Program is made available from DHCD's Community Legacy Program.





SUNSET PARK AND SOMERSET PLAZA Music & Events

The OCDC looks forward to partnering with the Town of Ocean City to bring another summer of Sunset Park Party Nights to Sunset Park. These events will be held Thursday nights starting July 11th thru August 29th at 7:00 pm. These events are free and open to the public. The Ocean City Recreation Boosters will be selling beverages and beer at each event. Proceeds from such sales go to youth programs in Ocean City.

Greetings,

With another successful year under its belt, the OCDC is now in its second decade of revitalizing downtown Ocean City.

What is successful?

Successful is the continuation of the Façade, Fence and "Green Building" Programs. These programs provide grant money from the State of Maryland to business and property owners.

Success is completing over 130 Façade Projects, increasing the tax base along with repairing older buildings with a facelift.

Success is having Ocean City designated as a Main Street Program. This innovative idea started in 1998 to help Maryland communities to grow and prosper.

Success is Sunset Park and Somerset Street Plaza for music and street events. This is one of OCDC's most popular programs as experienced by increased attendance every year.

Success is the annual golf tournament, named after Art Davis, one of our founding members. It provides a local funding source and is a great way to network and socialize after the season.

Success is public art located throughout Ocean City, not just downtown. New wall murals, painted utility boxes and pieces of sculpture add to the look and feel of Ocean City.

OCDC continues to provide housing for seasonal city employees. Lifeguards, police officers and other city employees fill over 40 beds in our downtown properties.

For 2013, a brand new Boardwalk was completed after a two year project. Next to the Beach, the Boardwalk is our best attraction. It is America's longest linear mall. At Caroline Street a new comfort station with a beach side performance stage is ready to go.

With the on going support from the Town of Ocean City, Worcester County, along with the State of Maryland, our efforts will continue to succeed.




OCDC EXPANDS TO **BOARDWALK**

In April 2012 the Boardwalk Development Association, which was established in 1999, became part of the OCDC organization.



The OCDC set up a new Boardwalk Committee which provides input into various boardwalk issues such as outdoor display review, marketing, etc... At the current time two major Town of Ocean City projects are underway on the boardwalk: 1) final phase of boardwalk reconstruction and 2) construction of a new comfort station and entertainment stage at Caroline Street. The OCDC has expanded its façade and green building programs to Boardwalk buildings.



OCDC Green Building INITIATIVES PROGRAM



This new OCDC initiative commenced in 2011 with the help of a DHCD grant. The aim of the program is to improve the energy efficiency of downtown businesses and multifamily buildings by installing items such as Energy Star rated windows and doors, improved wall insulation, and sun reflecting roof shingles. To date, 18 businesses and buildings have been improved using this program.

DHCD GRANTS TO HELP OCDC WITH 3 PROGRAMS

For the 2013 year, the OCDC was awarded a total of \$150,000 in grants from the Maryland Department of Housing & Community Development. These funds will be used towards the OCDC Façade Program, a new Business Assistance Program, and decorative street lighting for St. Louis Avenue.

In October 2012 the OCDC held its 12th annual golf tournament to raise funds for its downtown redevelopment program. Sysco Eastern Maryland, LLC was once again the prime sponsor of our golf tournament. This year's golf event was the OCDC's most successful fundraising tournament. Employee Housing

For its sixth year, the OCDC has provided and managed seasonal housing for Town of Ocean City seasonal employees. Since 2007 thirteen employees have resided at the Tarry-A-While Guest House that was constructed in 1897 and fully renovated in 2007. Ten additional Beach Patrol employees are provided housing at 110 Somerset Street. Additional employee housing for seasonal City staff for up to 26 people is provided at 105 Dorchester Street. Between its four managed buildings the OCDC manages 42 beds.


