OCDC Selected as BEST NON-PROFIT Organization

At its annual meeting held September 15 2015, the Greater Ocean City Chamber of Commerce selected the OCDC as the Non-Profit of the Year. This prestigious award was presented to the OCDC by the Community Foundation of the Eastern Shore.



Maryland Department of Housing & Community Development GRANTS to OCDC

For the 2016 year, the Maryland Department of Housing & Community Development has awarded the OCDC \$300,000 for three projects: Façade Improvement Program, Green Building Initiatives Program, and for demolition of the Royalton Hotel at 1101 Atlantic Avenue for development into a new mixed use project. DHCD grants have been instrumental in the success of our revitalization projects in Ocean City.

Revitalizing Downtown OCEAN CITY ONE BUILDING At A Time.

As of March 1, 2016 a total of 177 buildings have been renovated using the OCDC Façade Program in downtown Ocean City south of 17th Street. There are currently three façade projects underway.

The OCDC Façade Program has a tremendous impact on the appearance of many buildings. To date, over \$5.8 million has been invested into downtown Ocean City through this program. These newly renovated projects greatly increase the taxable value thus benefitting all Ocean City and Worcester County residents. Funding for the OCDC Façade Program is made available from DHCD's Community Legacy Program.

- Decorative street lights and LED lighting along St. Louis Avenue
- Employee housing in the fully renovated Tarry-A-While Guest House

Decorative Street Lights PROJECT COMPLETED

For the past three years the Town of Ocean City has been completing phased comprehensive street improvements along St. Louis Avenue between 17th Street and the Route 50 Bridge. This final phase was completed in May 2015. For each of these years, the OCDC has received generous funding assistance from the Maryland Department of Housing & Community Development to install decorative street lights with energy efficient LED lighting for each of these construction phases. This decorative lighting adds a lot to the pedestrian look of this residential street.

OCEAN CITY BEACH PATROL BUILDING *Completed*

The new Ocean City Beach Patrol building located at S. Philadelphia Avenue and Talbot Street was completed for the 2015 summer season. This building houses the OCBP headquarters as well as the bicycle unit of the Ocean City Police Department.

It is a tremendous addition to the downtown area. The OCDC assisted this project by providing its land through a real estate exchange with the Town of Ocean City, as well as supporting the use of Inlet Parking Funds to help finance the construction of the building.



DOWNTOWN CRAFT BEER FEST

a Huge Success

On October 24th, Shorecraft.com, OCDC and the Town of Ocean City teamed up to present the first ever craft beer festival held in downtown Ocean City at Sunset Park. This event was a great success with twelve craft breweries from Delmarva offering over 25 beers to sample. Food trucks and music was provided.

OCEAN CITY *Clean Sweep*



In November 2015, the OCDC held its third annual "OC Clean Sweep" event in downtown Ocean City. Over 50 volunteers, including volunteers from local schools and organizations, walked through the downtown area picking up trash and litter. The next clean up event will occur in November 2016.



MODEL BLOCK PROJECT

Since its inception in 2000, the OCDC has envisioned the assemblage of land in the downtown area to attract a sizable development to occur in the inner blocks. The Town of Ocean City and OCDC have assembled most of the block between Somerset and Dorchester Streets between S. Baltimore and S. Philadelphia Avenues. The first steps in this revitalization project, the demolition of the substandard buildings has been completed. An interim public parking lot will be created and operated while a developer is pursued. The end result will be a new project benefitting the downtown area with increased pedestrian activity and vitality. The new project will also provide an increased tax base benefitting the Town of Ocean City, Worcester County and State of Maryland.

Employee HOUSING

For its ninth year, the OCDC has provided and managed seasonal housing for Town of Ocean City seasonal employees. Since 2007 thirteen employees of the Ocean City Beach Patrol have resided at the Tarry-A-While Guest House that was constructed in 1897 and fully renovated in 2007.

Public Art CONTINUES IN OCEAN CITY

The OCDC and its Public Art Committee are nearing completing with the latest major public artwork called "Dance Of The Dolphins." The concrete foundation base, installation of the dolphin sculpture, and foundation tile were completed in 2015. The brick paver and landscape plaza to complement the sculpture will be completed in 2016. The sculpture was completed by noted Eastern Shore artist David Turner of Turner Sculpture.
